It is for information of all concerned that in exercise of powers conferred under section 30 sub section 2(B) of the Assam State School Education Act,2024, the ASSEB, Div-II, constituted to regulate, supervise and develop the system of Secondary School Education in the state of Assam has formulated the regulations for defining the Scheme of Studies of Secondary course (Class XI and XII) along with the conduct of activities relating to Admission, Provisional Recognition and Affiliation and Examination process.

The Academic regulations for Secondary Courses (Class XI & XII), 2025 is notified herewith with a note that this will be in force w.e.f. the academic sessions 2025-2026 to Class XI and from academic sessions 2026-2027 to Class XII.

## **ACADEMIC REGULATIONS FOR SECONDARY COURSES (Class XI & XII), 2025**

In exercise of powers conferred under section 30 read with section 30.2.(B) of the Assam State School Education Act,2024 the ASSEB, Division –II, constituted to regulate, supervise and develop the system of Secondary School Education in the state of Assam, formulates the following regulations for defining the Scheme of Studies of Secondary Courses (classes XI & XII) along with the conduct of the activities relating to Admission, Registration and Examination.

#### 1. SHORT TITLE AND COMMENCEMENT:

- These regulations may be called the Academic Regulations for Secondary Courses (Class XI & XII), 2025.
- ii. These regulations shall come into force with effect from the 2025-26 Academic Sessions for the Regular and Open Learning Courses of ASSEB, Div-II.

#### 2. **DEFINITION:**

In this regulations unless there is anything repugnant to the subject or context-

- i. 'Act' means the Assam State School Education Act, 2024 (Act No. ASSAM ACT NO. XI OF 2024)
- ii. ASSEB, Div-II means the Division for imparting Secondary Education (Class XI & XII), Assam.
- iii. 'Govt.' means the Government of Assam
- iv. 'Examination' means the Class XI Annual Examination as well as the H S Final Examination, as the case may.
- v. 'Course' means the Secondary Course (Class XI and XII) prescribed by the ASSEB, Div-II.
- vi. 'Candidate' means a person to whom permission to *appear* for H S Examinations has been accorded by the ASSEB, Div-II on the fulfilment of conditions as specified by the ASSEB, Div-II.
- vii. 'Student' means a person who undergoes the Secondary Education Course.(Class XI & XII)
- viii. All the words and expressions have meanings respectively assigned to them in the Act.
- 3. The Secondary Education (Class XI & XII) shall comprise of three streams viz. Arts, Science and Commerce.
  - The Vocational Stream has been replaced by Skill Subjects w.e.f. the academic session 2025-2026.





- The subjects offered under the Vocational Stream will be offered as Skill Subjects in integration of Academic Elective as per guideline of NEP-2020 and NSQF-2013.
- 4. Any student after having passed the Class 10<sup>th</sup> / HSLC examination from ASSEB Div-I(Erstwhile SEBA)/or any other recognized boards of Govt. of India as well as Govt. of Assam may take admission in the H S Course Curricula.
- 5. The duration of the Secondary course (Class XI and XII) shall be of two (2) consecutive academic years. Except otherwise stated in the Regulations, a student shall prosecute studies for the duration of the Course in a recognized institution so as to become eligible to appear in the H S Examinations.
- 6. The scheme of studies (curriculum) for Arts, Science and Commerce streams includes the subjects to be opted, Examination pattern, passing criteria and other matters related thereto shall be as detailed below.
- 7. Each period of instruction shall be of 45 minutes duration. The Board may, however, relax the duration of a period to 40 minutes on special consideration.

## 8. REGISTRATION OF STUDENTS

The registered students of ASSEB, Div-II will only be allowed to appear in the Class Xi Annual Examination and H S Final Examination.

Any student having passed the Class  $10^{th}$  / HSLC examination from ASSEB Div-I(Erstwhile SEBA)/or any other recognized boards of Govt. of India as well as Govt. of Assam may take admission in the H S Course Curricula.

## 9. Change of Subjects/ Stream

- Students are to be counseled to offer those subjects in Class XI which they would like to continue in Class XII and are available in the school at the time of admission as well as having competent teachers.
- However, to address some unwarranted issues, such as medical/ any exigencies or if the student is not capable of coping with the subject(s) etc., request for change of subject(s) in Class XI & XII will be accepted provided such a request has been made before 31<sup>st</sup> October for Class XI and 15th July for Class XII of that particular academic session.
- Students of Arts & Commerce Stream would not be allowed to change their stream to Science stream. Such students have to take re-admission in Class XI.





## Standard Operating Procedures have been framed as under

\*\*\* Change of Stream from Arts and Commerce to Science will not be allowed.

#### 10. Enrolment:

A. The stream wise enrolment per section for the both H S Schools and Senior Secondary schools and Degree Colleges shall be in accordance with the permission provided by the Board, keeping in view the availabilities of accommodation and teaching staffs.

The ASSEB, Div-II will monitor the transaction of classes and will introduce new subjects as per the need of hour for better academic upliftment of the students.

B. The enrolment of students in Skill Subjects should not be exceeded 50 in a subject as far as practicable. However, if any, institution proposes to admit more than 50 students in a subject, necessary permission is to be taken from the Board submitting the detail of the availability of infrastructures as well as practical classes/ hands on facilities

#### 11. Examination Hours:

The duration of examination hours of each theory and practical paper shall be as indicated below...

- The H. S. Final Examination as well as Class XI Annual Exam will be conducted by the ASSEB Div-II at the Govt. /Provincialised institutions in consultation with the Principal of the Lead College of the district and Inspector of Schools concerned.
- The result of the H. S. Final Examination will be determined on the basis of the marks obtained in H. S. Final Examination only.
- No credit of Class XI Annual examination shall be counted towards the result of H. S. Final Examination.
- The H. S. Final Examination shall be held in the month of February-March.
- Internal Examinations shall be conducted by the institutions for the students of the Class XI and class XII to accelerate their regular study habits.

- ASSEB, Div-II will conduct Repeat and Compartmental examination etc. maximum within 3 months from the date of the declaration of the H. S. Final Examination results.
- The District Committee will conduct the annual examination of the Class XI every year. Detailed modalities for conduct of Class XI Annual Examination will be notified in due course.

## 12. Unit Test - Half yearly - Annual Exam & Revisionary Test

- The District Examination Committee will-conduct Internal Examination of Class XI and XII as per Guideline including Annual Examination of Class XI. The Question Papers should be concept based as far as practicable.
- The district Examination Committee will conduct revisionary test (earlier termed as PRE TEST) for
  H. S. 2<sup>nd</sup> Year class through the concerned institutions to assess the student's understanding of
  previously learned topics by providing them with an opportunity to review key concepts and identify
  areas where further study is required. The main motto is to help the students to prepare for the
  upcoming examinations and improve their overall knowledge retention.
- ASSEB, Div-II will provide a portal to enter the marks secured by each candidate in all the Internal Examination. The student whose marks of Unit Test-1/ Half Yearly Examination of Class XII are entered in the portal will only be eligible to appear in the H. S. Final Examination.

# 13. The Scheme of Study for Secondary stage (Class XI & XII)

- There will be 6 compulsory subjects in total for all students.
- Subjects to be taken in each stream are divided in groups namely A, B, & C.
- A student shall opt for the Core subjects listed under part A and Elective subjects listed in Part B & C as specified.
- Each student has to opt for 4[Four] elective subjects compulsorily. These elective subjects will be of 100 marks, may be with practical or without practical.
- In addition to the 4[Four] elective subjects, a candidate shall have to compulsorily study Environmental Education in Class XI and General Studies in Class XII. The assessment of the subjects will be done internally by the institution where studying and Grade will be awarded.

### Relaxation for CWSN candidate

In case of Physically handicapped, dyslexic, autistic, spastic, mentally retarded and candidate with disabilities defined in the Right of Persons with Disabilities Act, 2016 certified by competent authority, as the Second language is exempted, instead of the 2<sup>nd</sup> language, they have to opt one



additional Elective subject. In case of this category of students, the no. of Elective subject will be 5[five] instead of 4[Four]. They may select either English or MIL/Alt.Eng from Group A.

### **Passing Criteria**

#### PASS MARKS FOR CLASS XI ANNUAL EXAMINATION

- In the Class XI Annual Examination, a candidate has to pass in both the MCQ type part and descriptive type part of the subject separately with 33% of marks as well as in the practical/ project portion and theoretical portion of the subjects, with compulsorily 33% of marks separately.
- ASSEB, Div-II will issue instructions to Internal Examination Committee to prepare 4[Four] sets of OMR for selected subjects to conduct the examinations. The list of selected subjects shall be notified time to time.
- After completion of the evaluation of the scripts and online posting of marks of Annual Examination of Class XI, ASSEB will declare the result and e-Marks Sheet will be issued to the candidates.

#### PASS MARKS FOR H. S. FINAL YEAR EXAMINATION

- The minimum pass marks is 33% of the total mark for all subjects.
- For a subject having practical/ project parts the minimum pass marks shall be 33% of the marks allocated to the theory part and 33% of the marks allocated to the practical/ project part.
- In H. S. course curricula, the student must have to appear in 6[six] subjects and the result will be declared as PASS, only if the students will secure 33% of marks in aggregate, in spite of the fact that even if he/she fails in one subject. However, passing in English and MIL/Alt. Eng. is compulsory.
- As a candidate will offer 6 subjects, the decision to determine the best 5 subjects may be taken by the admitting institution/ employer. Further, it is informed that the ASSEB, Div-II does not calculate/ declare/ inform percentage of marks. If the percentage of marks is





- required for higher education or in employment the calculation, if any, may be done by admitting institution or employer.
- ASSEB Div-II will award subject-wise grades to the candidates in class XI from the academic year 2025-26 & in H S Final Examinations from the academic year 2026-27 along with the marks secured by them in each subject. The awarded grades shall be reflected in the Marksheet cum Certificate issued to the candidates of class XI & XII as mentioned above.
- In skill based subject(s), the ratio of practical and theoretical part will be in the ratio of 50:50.

## **Passing Criteria for CWSN**

• In case of Physically Handicapped students, passing either in English or MIL/Alt. Eng. and the remaining 4[Four] elective subjects is compulsory as per Board's passing criteria to get the passing certificate.

## **Repeat and Compartmental Examination**

- Passed out candidates can appear in the Repeat and Compartmental Examination only once either in all the subjects or in any number of subject(s) as per his/her requirement for future course of studies for improving academic performance.
- If any passed out candidate appears in Repeat and Compartmental examination for improvement of Academic performance, then the better of the two marks obtained by the candidate will be reflected in the Marks-sheet. [It will be carried out on experimental basis initially for 2[two] years w.e.f H S Final Examination, 2027]
- The students appearing in the Revised Betterment of Result Scheme need not to appear in Practical/Project Examination if subject(s) contains Practical/Project. The original mark obtained earlier for the above shall be considered for the fresh mark-sheet.
- Unsuccessful candidate can appear in the Repeat and Compartmental examination in the subjects which he/ she has selected in the previous Regular examination to pass the H S Final Examination.
- Candidate who was absent in maximum 2(Two) no. of subjects in the previous examination may appear in the examination.
- In Repeat and Compartmental Examination, every candidate has to bear the Fees. Subject wise fees will be applicable in case of such examinations.

# SEPARATE GUIDELINE ON CONDUCT OF EAXMINATION WILL BE ISSUED.

#### **Notes**

- It is desired that student of all streams shall choose their elective subjects keeping in view of their future courses of higher studies in general and other professional courses in particular.
- Every learner at the +2 stage would be required to participate compulsorily in an area of cocurricular activities (CCA) out of NCC, NSS, Rover/ Ranger, Games and Sports (Any one from Athletic and other team games), Cultural and Literary, Debating, Quiz etc..



- A student must attend the minimum number of classes as specified under the Regulations to become eligible to appear in the H.S. First Year or H.S. Final Examination as the case may be.
- It is desirable that for ensuring adequate exposure to the prescribed laboratory techniques practical classes must be started in H. S. First year class.
- For providing of additional certificates to the students for acquiring skills by taking one subject from group C, each district will have to choose some agencies in their district. Detailed guidelines will be provided in due course.
- The Board desires that Unit test should be held regularly as indicated in the Academic Calendar.

#### PERMISSION-RECOGNITION

- In case of Government /Provincialised institution /SSA established institution upgraded by Govt.
   Provisional Registration and Affiliation shall be accorded as soon as receipt of Provincialised/
   Upgraded order from the competent authority and on receipt of requisite payment.
- The Provisional Registration and Affiliation fee is Rs. 15000 irrespective of stream(s) (for Government / Provincialised institution / SSA established institution upgraded by Govt.)
- In case of Private institution Provisional Registration and Affiliation shall be accorded on receipt of
  application in prescribed format with all required information particularly of land and building and
  order of Provisional/ Final Registration received from competent authority under relevant Acts and
  Rules of Government of Assam and after proper inspection as required. Final order shall be issued
  only after receipt of requisite fee. If, the inspection is instituted, the actual cost of the inspection
  should born by the Institution concerned.
- The Inspection Team will be consisted of the Principal of the Lead College, The Inspector of Schools and a Noted Academician of the concerned district.
- The Provisional Registration and Affiliation fee is Rs. 15000/ per stream(for privately run institutions).
- If an institute applied for permission of any one of the subjects from Physics, Chemistry or Biology, that institution shall be treated as an institute of Science stream. This institute must have separate laboratories for Physics, Chemistry and Biology. There should also be laboratory for the subjects like Mathematics, Geology and Anthropology etc. where ever applicable.
- If an institute applied for permission of the subjects Accountancy and Business Studies, that institution shall be treated as an institute of Commerce stream
- If any subject requires laboratory infrastructure, then the school must have such facility.
- Schools having subjects such as Dance, Music etc. must be recognized by some certified institutions as mandated by the Govt.
- After completion of 1(One) year of issue of the Provisional Registration and Affiliation, and after receipt of satisfactory report of physical verification to the effect that all conditions/ requirement of registration and affiliation are in order, such Provisional Registration and Affiliation shall be treated as absolute until withdrawn.





- After completion of 1 year of issuing Provisional Registration and Affiliation, each institution has to pay the renewal fee of Rs. 1000/ first at the time of Registration of Students for class XI and again at the time of form fill up of HS Final Exam.
- The Board may withdraw the permission, if it is found that the institution had violated the
  instructions of the Board, indulged in unfair means, Results are unsatisfactory, non enrolment of
  students continuously for three years, ethical lapse etc.

## ADDITIONAL SUBJECTS IN GROUP C

Add on certificate course :

Students of H. S. Course are also allowed to register simultaneously in Infosys Springboard, which offers a variety of free, online digital learning and re-skilling programs focused on digital literacy, competency, and proficiency, including courses in areas like experience (Infosys Aster), insight (Infosys Topaz), innovation (Blockchain), acceleration (Enterprise Agile Dev Ops), and assurance (Cyber Security). These may be treated as subject from Group C and marks awarded by the Infosys will be incorporated in mark sheet of Class XI and XII.

## PROVISION OF ADMISSION IN ASSAM STATE OPEN SCHOOL

- ASSEB, Div-II provides an alternative mode of school education in a flexible manner in order to cater
  to the needs of the learners who want to continue the H.S. Course. The drop out, unsuccessful
  learners and the learner desires to study certain subjects may get enrolled in the course.

  - A. **Regular Admission**: Any class 10<sup>th</sup> passed out.
  - B. **TOC Admission**: Unsuccessful students of H. S. Final Examination within 5[Five] years of appearing in the examination.

#### Passing Criteria for SOS

- A minimum of 33% marks in the aggregate in 5 subjects including at least one but not more than two languages as well as separately in theory and practical in the Examination.

# **Introduction of New subjects**

- Three new subjects will be introduced in class XI from academic year 2025-26 and from next year in class XII in the colleges and schools where wiling and competent teachers are available.
  - Sign Language: Will be introduced in colleges and schools where teacher or resource person is available having B.Ed. in special education. Any such competent teacher available in any primary or upper primary or high school or resource person of SSA, he or she may take classes of this subject in nearby HSS/ SSS/ college. The training of these teachers on Sign Language will be provided by ASSEB, only after enrolment of students in class XI.
  - Artificial Intelligence: Will be introduced in colleges and schools where teacher or resource
    person is available having personnel interest in this subject. Any such competent teacher
    available in any Higher Secondary or Senior Secondary school or in any colleges , he or she
    may take classes of this subject in his/her HSS/ SSS/ college. The training of these teachers
    on the Artificial Intelligence will be provided by ASSEB, only after enrolment of students.
  - Financial Literacy: Will be introduced in colleges and schools where teacher or resource person is available having personnel interest in this subject. Any such competent teacher available in any Higher Secondary or Senior Secondary school or in any colleges, he or she may take classes of this subject in his/her HSS/ SSS/ college. The training of these teachers on Financial Literacy will be provided by ASSEB, only after enrolment of students in class XI in the month of June 2025.
